

**PAPARAZZI PICTURES
MODEL RELEASE FORM**



I, (model's printed name) (hereafter "Model"), in the interest of gaining valuable modeling experience and in exchange for photographs of myself, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, give to Paparazzi Pictures (hereafter "Photographer,") its legal representatives, successors, and all persons or corporations acting with its permission, unrestricted permission to copyright and/or use, and/or publish photographic portraits or pictures of me, and the negatives, transparencies, prints, or digital information pertaining to them, in still, single, multiple, moving or video format, or in which I may be included in whole or in part, or composite, or distorted in form, or reproductions thereof, in color or otherwise, made through any media in its studio or elsewhere for art, or any other lawful purpose (the "Pictures.") The terms of this Release shall apply to Pictures created by Photographer on the date(s) of this Release and/or within 24 hours of the signing of this Release regardless of the calendar date of creation.

In my own behalf, I hereby relinquish, give and assign to Photographer all right, title, and interest that I may have in the finished Pictures, finished product, negatives, reproductions, copies of the original prints and negatives, derivative works, products, advertising or other copy that may be used in connection therewith. In my own behalf, I further grant Photographer the right to give, sell, transfer, and exhibit such finished Pictures, finished product, negatives, reproductions, copies of the original prints and negatives, derivative works, products, advertising or other copy that may be used in connection therewith to any responsible individual, business, firm, publication, or to any of their assignees.

In my own behalf, I hereby release and agree to hold harmless Photographer, its legal representatives, assigns, and those acting under its permission or authority, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of the pictures, or in any processing tending toward the completion of the finished product, unless it can be shown that they and the publication thereof were maliciously caused, produced or published solely for the purpose of subjecting me to conspicuous ridicule, scandal, reproach, scorn and indignity.

I agree that the aforementioned exchange is for photographs delivered to me by Photographer in the format described as print, email correspondence or CD- ROM. I agree that, while I may use the Photos for purposes related to the promotion of my Modeling business, including but not limited to advertising, portfolios, composite cards, exhibitions, contests, and promotional internet web sites, I will not sell publication rights in any or all of the Photos without Photographer's prior consent.

I acknowledge that the photography session, all poses, positions and situations enacted in Photos covered in this release were conducted in a completely proper and highly professional manner without force, coercion, or threat whatsoever, and this release was willingly signed at its termination.

I certify that I am not a minor, and am free and able to give such consent, and that no prior contract or agreement prevents my granting this Release to Photographer. I agree to indemnify and hold Photographer harmless for any untrue statement I make in this Release, including but not limited to my certifications that I am not a minor and may freely enter into the terms of this Release.

The photographer gives Model "The right to publish" in any media with the following restrictions: Model must always publish Photographer's copyright notice every time and anytime Photographs are published. Photographs are to be published "as is" that is, without distortion or changing Photographer's original appearance, with the exception of blemishes and other similar touch-ups.

I agree that Photographer is under no obligation to provide me with any portion of any revenue gained from the sale, transfer, license or other commercial exploitation of Pictures. I further agree that if Photographer does provide me, in its sole discretion, with a portion of such revenues, that such provision shall not be a waiver or in any way abrogate any portion of this Release, and that acceptance of such payment shall signify my continuing agreement with the terms of this Release.

I agree that Photographer is under no obligation to market, exploit or otherwise attempt to use Pictures, and that any such marketing or use is at Photographer's sole discretion.

Unless Photographer violates the terms of this Release, I promise that I will in no way attempt to interfere with its or other people’s use of Pictures or seek any monetary value from it or any other person if they are used in anyway. I promise that it is completely legal for me to sign this Release and, if it isn’t, I promise to make good any damages the Photographer suffers because of it.

I have read the foregoing prior to its execution and I am fully familiar with and agree to the contents thereof.

Image License

Photographer, the creator of the images above described (“Pictures,”) hereby licenses the copyright on some or all of the Pictures to the person above identified as “Model” under the following terms:

Photographer will provide Model with either print, email correspondence or CD-ROM containing the Pictures which are to be licensed to Model (“Promotional Images.”) The Promotional Images shall be of good quality, suitable for high-quality screen display for World Wide Web or similar electronic promotional use by Model.

Which Pictures Photographer provides as Promotional and/or Portfolio Images shall be at Photographer’s sole discretion, but Photographer shall provide not less than 10% of the total number of Pictures as Promotional Images and not less than Two (2) Portfolio Images, unless in Photographer’s judgment there is no suitable subset of the Pictures to meet these goals, in which case Photographer shall make a good-faith effort to provide a reasonable number of Promotional and Portfolio Images from those Pictures which are suitable.

Model’s license shall include the right to display the Promotional and/or Portfolio Images for purposes of self promotion. Photographer gives Model “The right to publish” in any media with the following restrictions: The model must always publish Photographer’s copyright notice every time and anytime the photographs are published. The photographs are to be published “as is” that is, without distortion or changing the photographs original appearance, with the exception of blemishes and other similar touch-ups. Model shall have no right to resell or re-license the Promotional and/or Portfolio Images for any other purpose, and this license shall be nonexclusive.
